INTRODUCTION

Chapter 1901 of the Ohio Revised Code governs the conduct of Municipal Courts including the Marietta Municipal Court. Section 1901.14(A)(4) provides as follows:

"On or before the last day of March of each year, the Court shall render a complete report of its operation during the preceding year to the Legislative Authority and to the Board of County Commissioners of each county within its territory. The report shall show the work performed by the Court, a statement of receipts and expenditures of the civil and criminal branches, respectively, the number of cases heard, decided, settled and such other data as the Supreme Court, the Secretary of State, the Legislative Authority, and the Board of County Commissioners required."

JUDGE'S COMMENTS

Facility issues related to Municipal Court dominated 2010. The Court purchased the former OBES property at 217 Third Street as a future home for the Court in 2009. The plans for remodeling that building as a home for the Court and Law Director were approved by City Council and put out to bid. The project was bid twice and did not come within the financial plan approved by Court and City Council. The Court then revised the building plans to reduce the footprint of the addition and simplify all design detail. The project is now out for re-bid.

All court employees attended various training and education classes including Court Security, Public Records Policy, Ethics for Court Personnel, Internet-E-mail Policy and Security, BMV training and Fire Safety Training.

The Court officiated at eighty-six weddings in 2010.

UNPAID FINES AND COSTS

The Court is owed \$330,215.13 for unpaid fines and costs imposed in calendar year 2010. Older cases are referred to the Court's collection agency, Capital Recovery, and the statutory thirty percent fee is added to the amount due. This collection fee is paid by the offender. The collection agency is not paid a portion of the fines and costs it collects. Collection efforts continue for prior years on accumulated fines and costs. Uncollected fines imposed prior to January 1, 2006 are deemed uncollectible but are subject to being reopened if the offender appears in court for another reason.

COST OF OPERATION

In 2010, the actual total of funds expended on Court operations from the City of Marietta General Fund was \$800,385.98. In 2009 the funds expended on Court operations was \$776,010.01. This expense in 2010 is partially offset by the payment of \$534,015.77 to the General Fund from court costs and fines.

The City Court budget for 2010 was \$888,563.68. In 2009 the budget was \$799,159.00.

In 2010 the Court expended \$14,400.00 from its Indigent Alcohol Fund, \$45,136.09 from its Computer Fund and \$265,399.64 from its Capital Improvement Fund. The Indigent Alcohol Account, the Computer Fund and the Capital Improvement Fund are separately generated through the Court by charging offenders additional costs.

2010 PROBATION REPORT

The Court ordered Secure Continuous Remote Alcohol Monitor (SCRAM) worn by sixty-three offenders in 2010 for a total of 5002 days of monitoring. This device monitors alcohol use twenty four hours a day, seven days a week. The data is transmitted by text messages to the Probation Department. A SCRAM requirement is sometimes imposed as condition of pre-trial release on bond. In other instances, an extended SCRAM requirement is imposed to complement alcohol treatment and in lieu of a jail sentence imposed by the Judge but not required by statute.

The Probation Department also administered and monitored Ignition Interlock and House Arrest Systems. They made 293 residence checks in 2010 as well.

The Municipal Court and its Probation Department partnered with Marietta College to provide four students 1060 hours of internship experience. These students assist in Court, and at Probation help with data entry, deliver restitution to victims and work to develop their expertise in their discipline with special projects.

Offenders worked 3,266 hours of community service in lieu of jail for numerous departments, worked which calculates to \$22,862.00. The Washington County Jail had 50 inmates work 2,994.25 hours of supervised community service totaling \$20,959.75 credited towards court fines in 2010.

All Probation Officers attended annual firearm qualifications, Line Officer Training, Motivational Interviewing and Ohio Risk Assessment System Training.
